

### NAR-ANON WORLD SERVICE CONFERENCE 2012

# Friday, April 20<sup>th</sup>: the WSC opened at 9:15 AM:

- The conference opened with a moment of silence, followed by the Serenity Prayer.
- The 12 Steps, Traditions and Concepts of Service of Nar-Anon were read as well as the SESH reading for April 20<sup>th</sup>.
- Welcome from Karen M., Board of Trustees (BOT) President.
- Introduction of the WSO Board of Trustees, the Delegates, Alternate Delegates, and World Service Committee members.
- Roll call was taken for all attendees (see list of attendees for names), 25 voting and 17 non-voting members as follows:

Voting: 16 delegates and 9 trustees.

Non-voting: 9 alternate delegates, 3 WSO staff members, 3 observers, the Chair of the WSC and Secretary of the WSC.

 A motion from the floor to accept the Standing Rules of the Conference as presented was made and seconded.

### Motion CARRIED unanimously - 25 for, 0 against, 0 abstentions (25/0/0)

• A motion from the floor to accept the WSC 2012 Conference Agenda.

**Motion 5:** During the next review and revisions of the bluebook, change the language in the blue book to be gender neutral i.e. he/she or they, them, themselves etc.

• Challenge to chair's ruling made from the floor. Parliamentarian present reviewed chair's ruling. Chair's ruling stands. Could be brought to conference as new business motion. Would apply to 2014 conference.

**Motion 11:** To approve the use of the Unity Prayer in Nar-Anon meetings and literature. The prayer is: "I put my hand in yours and together we can do what we could never do alone. No longer is there a sense of hopelessness. No longer must we depend upon our own unsteady willpower. We are all together now, reaching out our hands, for a power and strength greater than our own. And as we join hands, we find love and understanding beyond our wildest dreams."

- Chair's out of order ruling was challenged under "motion to reconsider" process of Roberts.
- Clarifications from Chair: no reconsideration of motions from previously closed business meetings.
- Motion to "suspend the rules" can be made, rules are suspended and motion can be dealt with.
- A motion, to suspend rules for reconsideration of WSC 2010 motion made and seconded.

"A moratorium shall exist on motions submitted to the WSC which are substantially the same as motions included in a CAR that failed at either of the two preceding conferences."

This motion shall take effect upon approval by the conference.
