Meeting was held by Skype and opened at 9:06 AM PT/12:06 PM ET/6:06 PM SAST with the Serenity Prayer.

The Twelve Concepts were read.

Roll call: 6 voting members present.

Approval of Minutes:

A motion to approve the minutes of the 10-25-2020 BOT meeting was made and seconded.

Secretarial Housekeeping: Motion to approve 1 poll posted since the October 25, 2020 meeting was made and seconded.

- Stripe Comparison, Jan. 1, 2019 Dec. 5, 2019 vs Jan. 1, 2020 Dec. 5, 2020
 Net volume from sales is down \$109,000 (34.3%)
- Bank Balance Dec. 5, 2020
 General Account: \$58,392.10
 Prudent Reserve: \$20,000.00
 WSC Account: \$38,632.46
 Credit Balance: \$7,021.75
- Final Balance Dec. 5, 2020 \$71,370.35

Highlights:

- Shipping Costs for January September 2020 were \$2,577.41 over what WSO received. This amounts to an average loss of \$286.38 per. month. A 6% increase can cover this shortage.
- CPA engagement letter was received with comments.
 - 1. Quick Books subscription increased. The amount noted is higher than actual increase.
 - 2. There has been an issue reconciling data entry for the Stripe account.
 - 3. **The CPA's** proposed monthly fee does not include the previously agreed upon discount for WSO performing data entry.
 - 4. BOT will investigate hiring a new CPA.
 - 5. BOT agreed to sign the engagement letter.
- Just For Today Bookmark based on writings from the Serenity Connection. WS Literature Committee asked the Executive Director to provide a template to submit the bookmark for production. A poll to approve the bookmark submissions will be posted.
- The costs of production have increased.

 - 7. CPA and Quick Books Increase: \$1,760
- Virtual Conference: Testing of equipment and balloting software is being tested. Runthroughs with a larger group will begin in January. Another BOT member will join the technical committee.
- History Project: The name of the ad hoc committee was changed to History Scribes. Use of the Nar-Anon logo by the committee was approved.
- Narateen Handbook and PowerPoint: WS Policy & Guidelines reviewed the handbook and did not find any issues.
